



Jems – Technical guidance

Version 2.0 Date: 09/11/22







This guidance contains key technical information on the operation and use of the joint electronic monitoring system (Jems) of the Interreg North-West Europe programme (NWE). Applications to the different NWE calls for proposals can exclusively be submitted via Jems (no offline template accepted). It is therefore highly recommended to read this document carefully before starting to use Jems.

This document will be updated on a regular basis: keep an eye on the North-West Europe website <u>https://www.nweurope.eu/</u>.

Technical information and system requirements

Jems is a web application, which can be accessed with recent versions of most common browsers (e.g. Google Chrome, Microsoft Edge, Mozilla Firefox). The functionality of the system follows the common standards of web applications for entering and submitting data.

The English language is pre-defined and cannot be changed; it is the working language of the NWE programme.

1. Access and registration

Jems can be accessed at the following <u>https://jems.nweurope.eu/</u>.

To use Jems, each applicant must first register by clicking on "Create account" on the homepage and provide a set of credentials.

- First name / Last name: personal information of the applicant's contact person.
- **Email:** the email address of the applicant it will be used to log in and notifications will be addressed to it.
- **Password:** password which will be used to access Jems.

The minimum length of the password is 10 characters. It should contain at least one upper case letter, one lower case letter, one digit and one special character $(!,;?-_+\%\&=#@*:\sim)$.

The "Register" button turns active only once all mandatory information is filled in. Following the registration, a confirmation email is automatically sent to the email address provided in the "Create new account" form.

<u>Only after clicking the link on the confirmation e-mail</u>, the applicant will be able to log into the platform and create an Application Form (AF). In case you do not receive a confirmation e-mail, please check your spam folder and, if needed, get in touch with the **<u>NWE Jems Helpdesk</u> (jems@nweurope.eu)** for assistance.

Point of attention: In case you forgot your password, contact the <u>NWE Jems Helpdesk</u> (jems@nweurope.eu) with your email address used during the registration (no "reset password" function available in the current version of Jems).





2. Applying for a call

To create your application, click on "Apply" under the section "Call list" of your dashboard. At this point, insert the acronym of your project (which can be modified afterwards) and click "Create project application".

The newly created project application will be automatically listed under the section "My applications". The project ID is an automatically generated number given by the system – this number is unique and allows the programme to easily recognise a project.


All applications created by the user are listed at this level - the user can select a project and open it by clicking on the name.





3. User Management

The lead applicant can grant access rights to an open application to other users, namely project partners and/or collaborators. To this end, they have <u>first</u> to register in Jems and then provide the lead applicant with their email addresses.¹



The lead applicant can then enable new users in the "Project privileges" section (see left menu of an application in progress) by entering a full valid email address.

Users can be granted either:

- **read-only rights** ("view") user can access all the application sections without being in the position of making any change
- **edit rights** ("edit") user can modify/fill in all the application sections
- **lead applicant rights** ("manage") user has both edit rights, but also access to the management of the "Project privileges" section.

¹ Please be aware that also capital letters are important in this case: if a participant is registered as <u>name.lastname@mail.eu</u>, the system will not find the user <u>Name.Lastname@mail.eu</u>.

Please note that <u>only</u> users with "edit" or "manage" privileges can submit the application proposal. Therefore we strongly recommend to identify and designate the user responsible for the submission of the application beforehand (this person should ideally be the contact person of the "lead" applicant institution).

Point of attention: risk of overwriting information

To a certain extent, it is possible for different users to work in parallel (at the same time) on the same application. When working in parallel, users have to make sure that they are not working simultaneously in the same section or sub-section as there is the risk to overwrite information.

In this respect, granting access rights to other users should be done parsimoniously, and coordinating who is working when in the application is crucial for a smooth use of Jems during the application phase.


Users can be assigned to an unlimited number of application proposals, and they can also have different user privileges.





4. Filling in the application

The "project overview" page offers general information on the proposal, its application status, and the running call. Every application has a version number. Upon creation the project version number is set to "V.1.0" by default – the latter will remain unchanged until the submission of your proposal. The same logic applies to the status "Draft", which changes to "Submitted" right after the submission.



Applicants are invited to fill in the relevant sections and sub-sections listed on the left menu, which corresponds to the application template.



Point of attention: For Step 1, only certain sections of the application will be visible and need to be completed, which is why section C.4 (and a few others) of the application do not appear.

Clicking on the "bin" icon allows you to delete. Some sections can only be saved once all mandatory fields (marked with an asterisk "*") are filled in. All other fields may be subject to pre-submission checks which block the submission of the application form, for more information please see section 9 of this document. The order of the project partners, work packages, outputs, etc. follows the one in which they were added in Jems. This order cannot be changed unless the related sections are deleted and modified.

Jems provides warnings or requests of confirmation before leaving any section of the application. Always remember to save the data before leaving a section in the application; otherwise, changes will be discarded!

In addition, the following important aspects have to be remembered when filling in the application:

- Follow the maximum number of characters indicated in the different fields characters in excess will not be taken into account on Jems. Please note that the punctuation and spaces between words or paragraphs are considered as characters.
- Do not use the "Enter" key of your keyboard to save data while filling the forms as it may lead to unexpected results. Always use the commands provided by Jems interface.
- When filling in longer sections, please remember to regularly save in order to avoid losing data in case of interruptions of your internet connection or other technical issues.
- Being inactive for a long period may end automatically your session for security reasons and unsaved data is lost!






5. Budget and co-financing


(Only applicable in step 2 application form or small-scale project application form.)

The sum of the partners' budgets defines the overall project budget. Based on the financial data filled in at partner level, the overview tables foreseen in the section "D-Project budget" are then automatically updated. Each partner budget and contribution have to be defined under the tabs "Budget" and "Co-financing" at the level of the respective partner in the section "B-Project partners".



1- Defining partner budget options

Before filling in the partner budget, relevant flat rates have first to be selected by the applicant under the "Partner Budget Options".



Bypassing this very first step will affect the further partner budget elaboration – the selected flat rates impact the automatic calculation done by the system under "Partner budget".

Detailed information on budget options and flat rates can be found in the programme

manual (section 5.2 and section 5.3). Flat rates are pre-defined in Jems; the flat rate amounts are automatically calculated on basis of total real costs in another cost category/ies and visible in separate tables under "Partner budget".





2- Inserting the partner budget

The "Partner budget" section covers the six cost categories of the NWE: staff costs, office and administrative costs, travel and accommodation costs, external expertise and services costs, equipment costs and infrastructure and works costs.

No manual budget entry is possible for a cost category defined as a flat rate for the partner budget option (see the previous section "1- Defining partner budget options") – the related budget table is not editable, and the total amount is automatically calculated by Jems.

For a cost category based on real costs, a dedicated budget table needs to be created by clicking on the button '+Add'.

Point of attention (2): After the partner claim preparation costs, its partner contribution should be adjusted accordingly after the completion of the section "E.1 – Project lump sums".

8. Export function

When your application is ready for submission, it is recommended to save the final version as a pdf file.

Point of attention (1): The budget export should not be read as a pdf file, but as a csv/excel document (some browsers may use the ".pdf" extension /format by default – in this case, please try to use another browser).

Point of attention (2): Please note that depending on the settings of Microsoft Excel on your computer, you may have to convert the downloaded csv file into an excel file.





9. Submission of the application

The submission of your application follows a two-step approach. Each application requires a successful presubmission check of content before it can be submitted.

Under the section "Check & Submit", users with "edit" or "manage" privileges (see chapter 3 of this document) can perform these two actions:

- Run pre-submission check;
- Submit project application.

The "<u>pre-submission check</u>" function (A) warns applicants when mandatory fields of the application are not filled in – a completeness and consistency check is run by the system, **but** it does not check the quality of information provided. Therefore, it remains the applicants' responsibility to read carefully information included in our application guidance, go through their application, and verify that all necessary fields are properly filled in.

The button "<u>Submit project application</u>" (B) is accessible only once all pre-submission checks are successfully passed.




